MASTER PRESS AUTHOR'S AGREEMENT

Acceptance of Terms:

GRANT OF RIGHTS

This agreement is a non-exclusive agreement and may be terminated by either party at any time by notifying the other party in writing. In consideration of payment by the Publisher to the Author of Royalties, the Author as beneficial owner grants to the Publisher the right to reproduce the book on the following terms and conditions:

THE PUBLISHER

Hereby undertakes to publish the Work and to provide the following services upon publication whilst this agreement shall remain in force.

To create a place for the book to be displayed on the Master-Press.com web-site

To display a summary of the author's biography on the Master Press web-site

Free permanent storage of the electronic manuscript in the Master Press Digital Library.

To monitor all sales and maintain records of sales of the Book.

To maintain accounting records and submit reports and distribute royalties to the Author on the 30th day of June and the 31st day of December each year.

To print and sell the Book in accordance with the request of buyers including wholesalers, retailers, libraries or companies.

To provide the Author with information in respect of advertising of the book through Internet facilities (web-site, direct e-mail) as well as traditional means of promotion including reviews, fairs, exhibitions, signings etc.

To pay to the Author a royalty for each Book sold an amount of 55% off the selling book price after wholesale book sales from resellers via catalog, bookstores (Amazon, Ingram, Barnes and Noble)

To fulfill all other obligations for the promotion of the Book and the fulfillment of this agreement including all those contained in any appendix annexed hereto.

THE AUTHOR

Hereby grants to the Publisher the rights to the Work by the way of license to print and Publish the Work and any abridgement or substantial part of the Work in all editions in volume form in all languages during the tenor of this agreement.

Warrants that the work does not infringe upon or violate any statutory or common law rights and privileges of copyright or authorship or privacy or libel against others.

Indemnifies Master Press, against any claims, costs or damages arising from the publication of the Book and shall hold harmless all parties, employees, directors, shareholders and consultants of Master Press In the event of such claims, costs, damages arising.

Under this Agreement, the author grants Master Press nonexclusive rights to print and distribute the Work only. Master Press acquires no right of ownership to the Work under this agreement, and all publishing rights are reserved to the Author.

Author Right to Copyright

Master Press acknowledges the Author shall own full and complete Copyright to the Work. In order to protect the Author's full right to privacy and ownership in the Work, Master Press guarantees not to contact the U.S. Copyright Office on the Author's behalf.

Term and Termination

The Author may cancel this agreement at any time. The Author may enter into another publishing agreement for this Work at any time. Master Press shall not, however, refund to the Author any portion of the submission fee in the event the Author cancels this agreement or enters into another agreement for this Work. This agreement will automatically renew for consecutive one (1) year terms if neither party gives at least thirty (30) days written notice, prior to the end of the current term, that it desires to terminate.

Master Press is dedicated to publishing Christian books that bring life to readers. Therefore, we reserve the right to assign an alternate imprint to books or to cancel contracts on books we may find to contain: offensive material, libelous statements, graphic sexual content, graphic violence, profanity, content that is not consistent with traditional Christian belief and practice, or content that infringes on the copyright of another. (Should Master Press cancel a contract on these grounds, authors may qualify to receive a partial refund of submission fees minus costs of acquisition, production, and administration.) Such books will not be sold through the Master Press online bookstore or advertised in Master Press' Christian Book Browser catalog.

Distribution

Master Press intends to prepare the Work for on-demand distribution within sixty (60) days of the date of this Agreement, but the Author acknowledges that the production process may exceed that time period due to circumstances beyond its control. Master Press also agrees to secure a unique ISBN for the Work.

Author Warranties

The Author guarantees he/she is the sole owner of the Work and has the full authority and right to enter into this agreement. The Author guarantees the Work is original and does not infringe upon any laws or rights, and that the Work is not libelous, plagiarized or in any other way illegal. If any portion of the Work is fictitious, the Author guarantees it does not represent any real event or person in a way that could be deemed libelous. Master Press. assumes no responsibility for reviewing the editorial content of the Work.

Author Indemnification

The Author agrees to fully indemnify, defend and hold harmless Master Press, Inc., its employees, owners, and/or its affiliates against all manner of claims, losses, damages, judgments, settlements, or expenses (including attorney's fees) it sustains in connection with any breach or alleged breach of the representations set forth above, or in connection with claims by any third party regarding ownership, libel, slander, plagiarism, or privacy. Master Press reserves the right to cancel this agreement if breached by the author.

Terms of Sale

The Author is required to purchase 100 copies of the Work in the initial order. After that, the Author may purchase copies of the Work in any quantity. Orders must be paid for with check, money order, or credit card at the time the order is placed. Orders of less than one-hundred (100) copies shall be printed and shipped within five (5) to ten (10) days from receipt of order. Orders of more than one-hundred (100) copies may take an additional amount of to print and ship. All orders are shipped via United Parcel Service (UPS). The Author agrees to pay Master Press the actual UPS shipping charges for each order, plus handling fee of \$1.50. The publisher shall grant authors 55% off the retail price for books ordered directly from Master Press.

Master Press agrees to pay to the Author a royalty for each Book sold in the amount of 55% off the selling book price after wholesale book sales from resellers via catalog, bookstores (Amazon, Ingram, Barnes and Noble).

For example, if a book retails for \$10.00, our wholesale resellers will be able to purchase this book at the same 55% wholesale price. That means that there would be a \$4.50 profit (\$10.00 - \$5.50 = \$4.50). If the book costs \$2.50 to print, the profitability of the book is \$2.00 (\$4.50 - \$2.50 = \$2.00 profit). You as the author would receive 55% profit of the \$2.00, less any applicable shipping fees. The royalty received by the author for the book

in this example would be \$1.10. Keep in mind that these royalties are above and beyond any book sales that you might make through your own channels of distribution.

The publisher may occasionally offer discounts up to 65% off the retail price for bulk orders. Authors shall receive no royalties on copies they purchase from Master Press. Royalties are paid only on copies sold to bookstores, libraries, or directly to consumers.

Volume Discounts

When you publish a new book with Master Press, your initial order must be for a minimum of 100 books. After the initial order, however, you can order as little or as many books as you need.

For example, you have an upcoming conference and would like to have 40 books sent ahead of you to the conference destination. You can order the books in advance and have them drop-shipped to the destination so the books arrive before you.

Volume discounts are available for large orders, as follows:

for orders of 250 books or more 10% additional savings for orders of 500 books or more 15% additional savings for orders of 750 books or more 20% additional savings for orders of 1000 books or more 25% additional savings

Example:

500 books retailing for \$12.95 \$12.95 - 55% = your cost of \$5.83- additional savings of 15%= \$4.96 *plus all applicable shipping costs

Cover Design

Master Press will consider Author suggestions, but does not guarantee it can perform any unusual or special requests. The Author acknowledges that Master Press does not create original drawings, paintings, photographs or illustrations. The Author also acknowledges that colors viewed on a computer monitor or hard copy printed from a computer printer may not reflect the actual colors on the final printed book. Further, the Author acknowledges that cover color may vary between print runs. Under no circumstance shall Master Press refund, reimburse, or otherwise replace books printed with cover errors or color variance.

Text Format

Master Press reserves the right to determine the manner and style in which the Work will be formatted and typeset, using styles that are consistent with popular trade books, and using a Times New Roman font. The Author acknowledges that Master Press cannot guarantee it will perform any special or unusual formatting requests. The Author also acknowledges that Master Press cannot create an index for the Work, and cannot accommodate footnotes, only end of chapter or end of book endnotes. The author acknowledges that from time to time, though our accuracy is high, errors may occur in the typesetting process. Master Press shall perform one free round of corrections to fix Master Press errors proven by the author, at no cost to the author. But under no circumstances shall Master Press refund, reimburse, or otherwise replace books printed with such errors.

Miscellaneous Fees

All manuscripts are to be submitted to Master Press in complete and final form (already edited, copy edited, and proofread). After submission, Master Press shall perform one free round of corrections to fix Master Press errors (proven by the author) at no cost to the Author, prior to proof being approved and printed. Typological errors cause by Author will be corrected at Author's request and billed at our Interior Designer's hourly rate plus interior resubmission fee and proof printing price. Under no circumstances shall Master press refund, reimburse, or otherwise replace books printed with such errors. Authors should review interior draft carefully for typographical errors before signing off on it and ordering a proof.

Graphics

The Author may submit graphics in the form of tables, charts, black and white photographs, drawings, or other illustrations. Master Press shall charge a fee of \$15 per graphic on disk, submitted in acceptable form (see Master Press' Text & Graphics Guidelines); \$25 for graphics not on disk (submitted in scannable form, properly sized); \$5 for each graphic in a book to be scanned. All fees are payable upon execution of this Agreement. All graphics submitted with the Work must comply with Master Press' text and graphic guidelines. Please be advised that Master Press will place these graphics with appropriate captions provided by the author. (Fees are subject to change without notification).

Publisher Discretion

Master Press shall have the discretion to determine the retail price, production, format, and appearance of the Work. The format and appearance of the Work may vary between printings. Retail prices are subject to change, but under no circumstance may the Publisher increase the price of the Work by more than one dollar (\$1.00) per annum. After the end of the first year of publication of the Work, Master Press may charge the Author an annual publishing maintenance fee of \$24.95 to keep the Work in print and available for distribution.

Master Press, Inc. reserves the right to remove the Master Press logo from any book when deemed necessary by the Publisher. Master Press also reserves the right to decline to publish or revise any book. Master Press reserves the right to revise, replace or update distribution, promotional or marketing initiatives as necessary or due to circumstances beyond its control. Any royalties due which are less than \$25.00 in any one quarter shall be carried over and payable in the next accounting quarter.

Damage or Loss of Materials

Master Press shall endeavor to care for and return any disks, manuscripts, photographs, or artwork, but is not responsible for any damage or loss.

Law and Venue

The parties understand this agreement is binding upon their heirs, executors, administrators, and assigns. This agreement supersedes other oral or written agreements, and cannot be modified except by the mutual written agreement of Master Press and the Author. The laws of the State of Florida shall govern this agreement, and its courts shall be the venue for any litigation.
